Rise Up for Kids Faith Agreement

Rise Up for Kids operates as a Christian faith-based organization. Rise Up! recognizes there is a wide range of theological views in the Christian community. Rise Up! is not a church and we do not expect all staff, Board Members and volunteers to adhere to a specific Christian viewpoint. However, Rise Up! believes it is necessary to have all staff, Board Members and volunteers agree on the basic tenets of the Christian faith. By so doing we will avoid giving conflicting messages to the youth and families we serve and to the public. We recognize that for many people there are important details that are not included in the Faith Agreement below, but consistency in presenting the immutable tenets of the Christian faith is our primary concern. If material violation of our Faith Agreement occurs it may result in termination with Rise Up, with Rise Up being the determiner of such violation. By signing this document, you are testifying that you agree to the following:

- I. I attend church on a regular basis and can provide a reference from a church leader.

- II. I have a Biblical world view in that I believe:
 - 1. The Bible is the Word of God
 - 2. The Bible is accurate in all the principles it teaches
 - 3. Unchanging moral truth exists and is defined by the Bible
 - 4. Jesus Christ was and is the Son of God
 - 5. God is all powerful, all knowing, and the Creator of the universe who still rules today
 - 6. Salvation is a gift of God and cannot be earned
